THE Mangaluru City Corporation (MCC) will submit proposals to the Central and state governments seeking Rs 1,250

According to police sources, on Wednesday night, Prathap sexually assaulted his sister-in-law. During the assault, Suchitra's four-year-old son, Charan, intervened and tried to stop the act. However, Prathap brutally attacked the child and pushed him off with force, inflicting severe injuries on the head. Charan died on the spot. Following a complaint filed by the victim's mother, Suchitra, the Virajpet police registered a case of rape and murder against Prathap. The accused was arrested and further investigations are ongoing. Kodagu Superintendent of Police Bindu Mani R N visited the crime spot to oversee the initial investigation.

CITY POLICE BOOK 7,490 PARKING VIOLATION CASES SINCE JUNE

Mangaluru: THE Mangaluru city police have registered 7,490 cases against motorists for parking and traffic violations since June 2026 as part of special drives aimed at improving pedestrian safety and ensuring smooth traffic movement. According to the city police commissioner Sudheer Kumar Reddy, Rs 3.07 lakh in fines has been collected during the period. The cases include 1,080 instances of parking vehicles on footpaths, besides violations involving no-parking, wrong parking, double parking and traffic obstruction. In a separate special drive conducted from August 4 to 12 to curb the use of fake, defective and missing number plates, police registered 332 cases and imposed fines totalling Rs 3.01 lakh. Of these, 258 cases involved defective number plates, while 74 vehicles were found being driven without number
