## Delay in recruiting screeners

THE delay in recruitment of staff at  
the screening facility at domestic  
cargo terminal at Mangalore Inter-  
national Airport has affected dis-  
patching of the same via flights for  
more than a year. Due to this, the  
cargo is delayed by a day since it is  
taken by road to Bengaluru and from  
there it is dispatched via flights.

The cargo terminal functions under  
AAI Cargo Logistics and Allied  
Services Company. Domestic cargo  
was handled by a Mumbai-based  
company till 2020 and after it stopped  
its services, a new facility was set up  
and operations got final approval

only this February from the Bureau  
of Civil Aviation Security (BCAS).  
But the operations are yet to start as  
the recruitment of screeners is yet to  
be completed.

It has affected the delivery of vari-  
ous cargo items. "Since there are no  
flights available from Mangaluru, we  
are dispatching the cargo through  
trains and on road by trucks. We  
have to dispatch it to Bengaluru  
overnight using a dedicated vehicle  
and from there it is sent through  
flights to other hubs. Ours is a hub-  
to-hub approach. There are 89 hubs  
in the country under India Post and  
Speed post service comes under Rail-  
way Mail Services (RMS). We are fo-
